Resolution and Order No. 2024-348 An Intergovernmental Agreement for Transition Services Between Greater Albany Public **School District 8J and Linn County** \$100,308.00

This money comes through Title 1D funding which comes to GAPS because of the Linn Benton Juvenile Detention Center along with Jackson St. Youth Shelter (Albany House) being located in Albany within the 8J District.

Title 1D monies are calculated by an intake count taken in the month of Oct. This provides funding for the following year.

The partnership with GAPS regarding this funding has been outstanding. GAPS is the only district in the State of Oregon which provides the full amount of funding back to the two programs that are responsible for them getting it. Minus the administrative costs, GAPS provides this funding to support the Juvenile Department's services for youth in detention, transitioning in and out of detention and for educational assistance to Jackson St. Youth Services for their Albany House.

Services provided with this funding:

Linn Benton Juvenile Detention

- Education Transition Specialist (18 hrs. per week)
- .48 FTE for the Horticulturalist at the Linn Benton Detention Center
- Extra class room supports for the Detention Education Program

Jackson St. Youth Services

- Transportation assistance while the McKinney Vento program is set up
- **Tutoring**
- Summer Education Program

Resolution and Order 2024-352 Amendment No. 1

Personal Service Contract for Physician Services between VERITAS Direct Primary Care, P.C. and Linn County Not to exceed \$80,000

This contract is amended to increase the total contract amount by \$3,200.00 to cover some additional costs of prescriptions for youth. The Juvenile Department contracts for Physician Services for out Medical Director at the Linn Benton Juvenile Detention Center. A physician comes to the facility twice per week for a total of 4 hours. The previous contract amount of \$76,800 covered the cost of the physician only. The increased \$3,200 will also cover the cost of prescriptions, which are prescribed by this physician and can then be billed through our contract with them.

The Road Department has the following items on the Board of Commissioners agenda for the weekly meeting on October 22, 2024. The following is a brief description of the items.

Resolution & Order 2024-231 – Request for Proposals Advertisement, Cox Creek (Waverly Drive) Bridge Project

This is a Resolution & Order to authorize the publication of a request for proposals advertisement and set the proposal opening date for the Cox Creek (Waverly Drive) Bridge project.

Resolution & Order 2024-370 - Lease Agreement for Wodtli Quarry

This is a Resolution & Order to renew a lease agreement with Robert Potter, Trustee of the W. Allen Wodtli Living Trust, for the Wodtli Quarry. This agreement is for two years (retroactive from May 2023) and will allow the County to purchase and remove aggregate, utilize certain areas for aggregate, woody debris and excavated material storage. The cost to the County for aggregate removal is \$1.04/cubic yard for the first year with a \$0.02/cubic yard increase per year. The County will also pay a percentage of the property taxes equal to the percentage of area allotted for storage by the County.

Resolution & Order 2024-372 – Amendment to the North River Drive MOA and Delegation of Authority

This is a Resolution & Order to approve an Amendment to the Memorandum of Agreement for the North River Drive (CR 0035) Improvement project with the Federal Highway Administration and delegation of authority to Roger Nyquist. This amendment extends the period of performance to an end date of December 31, 2025.

Ordinance No. 2024-371

Ordinance No. 2024-371: Amendments to the Outdoor Assembly Code as requested by the Linn County Board of Commissioners from legal counsel in public meeting on or about July 9, 2024. The amendments eliminate the certificate of registration for Level 3 assemblies, and requires all levels of outdoor assemblies to submit a permit application, undergo reviewing authority review, have a hearing on the application, and obtain a permit to conduct an assembly. All levels of assembly are required to submit life safety plans, sanitary plans, etc. The event count number subject to regulation under the Code remains 500 or more attendees.

The amendments modify the penalty provisions so that first violations remain a Class A violation while second or subsequent violations will be specific fine violations punishable by a fine of \$2,000. Conducting an assembly without obtaining a permit will be a specific fine violation punishable by a fine of up to \$10,000.

Financial Impact: NA

Staff Recommendation: DO PASS with emergency clause for October 22, 2024 effective date.
