##### Statutory References and Other Authorities: ORS 203; HB 3400 (2015)

Section 134, Chapter 614, Oregon Laws 2015 (Enrolled House Bill 3400) provides that if a governing body of a county adopts an ordinance under the section, and provides a copy of the ordinance to the Oregon Liquor Control Commission, the Commission shall discontinue licensing premises which are prohibited by the ordinance, until the date of the next statewide general election.

LCC 571A.200 as adopted provided that “The ordinance adopting this Code, Ordinance No. 2015-379, shall be referred to the electors of Linn County at the next general election, Tuesday November 8, 2016.” At the November 8, 2016 general election the electors voted 46.12 percent in favor and 53.88 percent opposed, and the referral failed.
